FLTA dues are not deductible as a charitable contribution for federal tax purposes but may be deductible as a business expense. A change in the tax code eliminates the portion of your dues attributable to lobbying expenses. It has been determined that 85% of your dues are used for these purposes, therefore only 15% of your dues are deductible as a business expense, or 10% if you designate 5% to TIFPAC.

2022 Dues Schedule - The Board of Directors has approved the following dues schedule for the year 2022. Dues are from January 1 through December 31 of each year.

Insurer Membership:

The 2022 dues for insurer members will be computed at 1/10 of 1% (.001) on the first \$15 million of gross revenue and 1/100 of 1% (.0001) of all gross revenue in excess of \$100 million. The minimum dues for any Insurer membership shall be \$2,500.

For these purposes, gross revenue will refer to revenues from title premiums in the State of Florida. As there is a time lag in financial reporting, the dues for each year will be calculated using industry information available online from ALTA and will include gross premium for the 4 quarters ending in September of the preceding year. Thus for 2022 dues, the computation would be based on Premiums generated in 4th Qtr 2020; 1st Qtr 2021; 2nd Qtr 2021; and 3rd Qtr 2021

PAC dues are optional; please mark this box if you do not want to contribute 5% of your dues to the Title Industry of Florida Political Action Committee (TIFPAC). A contribution to TIFPAC does not increase dues.

The by-laws provide that all dues are payable on January 1, 2022 at the FLTA office and shall be delinquent February 28, 2022. Any member who is delinquent in payment of dues shall be suspended automatically and lose all voting privileges.

Only checks will be accepted for payment of annual dues.
